#### 6.2.1. A.D. Morgan Agreement

Mrs. Monbarren informed the Board that we were notified this past Friday, that Neumann Construction and Roofing, LLC closed their construction arm of the business and are no longer available to oversee the expansion of the Resource building and Ag classrooms. The permitting has started and will continue. A.D. Morgan has been contacted to see if they are able to take over the Resource and Ag Classroom expansion. They will let us know soon. The pre construction service agreement with Neumann Construction & Roofing, LLC covered three months, June to the end of August, and has ended.

#### 6.4.1. 1st Grade Team

The 1st grade team (four classes), Mrs. Felts, Mrs. Hines, Mrs. Dauphinais, Mrs. Moates shared their weekly activities, what learning programs are used and how they are implemented.

**Reading -** The students work with HMH Into Reading, sight words, vocabulary, comprehension and Lexia daily. Throughout their day Kagan structures are incorporated to make reading fun.

**Writing** - Throughout the year the students are introduced to different writing techniques, foundational skills (writing beginning, middle and end), opinion writing, narrative writing and informative writing.

**Math** - Students learning with hands on math through manipulatives using candy corns and popsicle sticks to learn addition and subtraction. Cooperative learning and peer coaching not only teaches math but also how to be a good friend, how to share kindly and show respect for others.

Science/Social Studies - The students learn through experiments and collaboration. The first part of the year they learned about citizenship and government. The sink or float - "Build a Boat" project was completed last week. Students learned why items sink or float. Field trips are another part of the science and social studies curriculum that not only teaches but also provides fun too.
