Several committee members did a site visit at Dayspring Academy Early College Program that was very insightful and provided an excellent overview of what can be done at our campus. The Dayspring Program /Model provides on campus instruction for freshmen and sophomores only. Juniors and seniors are taking college classes elsewhere with the option to come back to campus for study groups etc. This is a unique model geared for college bound students.

The committee will meet in January to open the discussion on what model will work for our setting, and to find our own niche to provide the best educational experience for future AATF high school students.
