7.2. Update Request

Ray Polk explained that based on legislative changes regarding the student lottery, students that are attending our preschool and have successfully completed the preschool program transfer to kindergarten and do not need to go through a lottery draw again unless there is no space. Our legal advisor verified that our preschool falls under the same statute umbrella as the school.

Earl Sturwold motioned to update policy 2.40 Controlled Open Enrollment Process by removing line item 14 d as presented; Lee Maggard seconded; all approved.

7.3. Plans for Expansion - Growth Model

Ray presented a growth model to open a fourth kindergarten class this upcoming school year. The additional classroom needed is available at this time and will add about 20 new students. He further shared that a \$1,000,000.00 grant for a resource building has been approved and we are able to use that money right away. With this in mind, the preliminary idea is to convert building 3 (currently our resource building) into classrooms for the intermediate team, build a new resource building on the new property and add another building to replace building 2 (oldest building) to increase classroom numbers for the primary team. The resource building will house all ESE and counselors' offices, therapy classes and music and art classes.

Will Bingham motioned to accept the \$1,000,000.00 grant for a resource building and expanding one class per grade level, starting with kindergarten for the next year; Lee Maggard seconded; all approved.

7.4. Florida Capital Bank - Steve St. Clair

The enclosed loan document is a simple extension of 18 month to the previous loan that originated about three (3) years ago for the land purchase. Interest rate and monthly payment will remain the same. To answer the question about the variable interest rate, Steve St.Clair replied that it is typical for a short term construction loan and it usually turns into a fixed rate loan later. Florida Capital Bank is entertaining to look at a fixed rate commercial financing without USDA backing for future projects.

Will Bingham made the motion to accept the loan extension document as presented; Lee Maggard seconded; all approved.
