PURPOSE:

CRITERIA:

This recognition will be for a person or business that has supported the Academy by devoting their time, energy and resources to the success of the Charter School throughout the history of the school. Examples should include but are not necessarily limited to: Charitable work and participation, philanthropy, education, and services that may have helped uplift and support the success of the school and the community it touches.

ELIGIBILITY:

The Nominee must be someone who has significantly been involved in the establishment, growth and continuing success of the Academy. Current governing board members, faculty and staff are not eligible.

THE NOMINATION PROCESS:

- Complete the attached nomination form prior to June 30th of the school year.
- Include a letter of recommendation from the person supporting the nomination.
- The letter of recommendation must explain "how & why" the service rendered by the nominee is extraordinary.
- List the "results" as they relate to the impact this person made on the Academy at the Farm Charter School
- All applications for Board Service Recognition should be sent to the Assistant to the Director's Assistant (Julia Spencer) no later than June 30th.
- Filling out an application and nominating someone, based on the criteria above, does not guarantee the applicant will be recognized.
- Nominations are considered for one school year. Nominators can update the nomination information at any time within the one-year time frame.

SELECTION:

The New Board Member Committee will review the applications in July and based on the criteria described will recommend the recipient(s) for the Board Service Award(s) to the AATF Board of Directors for approval in August.
